Winter is in full swing, by now you should have snow removal and ice maintenance all set up. If you are using Volunteers make sure ice melt is on hand and shovels and snow blowers are in good working order. If using a snow removal service have all the proper documents before work begins.

Snow makes for added water on floors. Be prepared for extra clean up. Slips and trips account for most claims this time of year. 

### BY-LAWS OF THE WYOMING ELKS ASSOCIATION

### **PREAMBLE**

The <u>subordinatemember</u> Lodges of the Benevolent and Protective Order of Elks of the United States of America, located within the State of Wyoming, affirming their allegiance to the Grand Lodge, in order to unite all Elks closer bonds of fraternity, promote the interests of the Order, exchange ideas beneficial to the <u>membermember</u> Lodges, foster the virtues of Charity, Justice, Brotherly Love and Fidelity, and to further patriotic devotion to the fundamental principles of government upon which our nation is founded, do ordain and establish these By-Laws.

### **ARTICLE I - NAME**

Section 1. This Association shall be known as the "Wyoming Elks Association."

### ARTICLE II - Membership

**Section 1.** Every <u>subordinatemember</u> lodge in Wyoming will be a member of this Association as per ARTICLE 3, Section 20 of the Grand Lodge Constitution.

**Section 2.** Each lodge shall pay dues to the Association based upon the number of members in good standing on April 1st of each year.

**Section 3.** On or before May 1<sup>st</sup> of each year the secretary of each lodge shall certify to the secretary of the Association the number of members in good standing in their respective lodges as of April 1<sup>st</sup>.

**Section 4.** Dues, in accordance with Section1, ARTICLE 5 of these By-Laws will be determined by assessing each lodge a per member charge based on Section 3 (above).

**Section 5.** Unless arrangements are made under Section 2, ARTICLE V, dues of each lodge must be paid to the State Treasurer at the same time as the membership report in Section 3 (above).

### **ARTICLE III – Delegates**

**Section 1.** The legislative powers at all meetings of the Association shall be vested in the certifies delegates.

**Section 2.** Each Lodge of the Association having complied with ARTICLE II, shall be entitled to representation at all meetings of the Association, whether regular or special as follows:

A Past Exalted Ruler (as defined in Section 1, ARTICLE III, of the Grand Lodge Constitution) of any member member lodge of the Association shall be considered a delegate at large.

Additionally, each <u>subordinatemember</u> lodge shall be allowed five (5) appointed "regular delegates." The Exalted Ruler may also appoint five (5) alternate delegates who shall serve only in the absence of the five regular appointed delegates. If a regular delegate is absent, then the duly appointed alternate delegate will have all the privileges of the absent delegate. The lodge secretary must submit a list of the regular and alternate delegates, as well as a list of eligible at large delegates to the <u>ChairmanChairperson</u> of the Committee on Credentials prior to the date of the annual Association Meeting. This list will remain in effect throughout the Association year.

Both delegates at large and regular (or their alternates) will have the right to vote on all matters of the Association requiring a delegate vote. In no case shall any delegate have more than one vote.

All delegates must be registered at the host lodge of the Association meeting to receive voting credentials. Non-registered delegates will be unable to vote on matters requiring a delegate vote.

Any lodge not in conformance of ARTICLE II of these By-Laws has no right of delegate vote.

### **ARTICLE IV - Meetings and Fiscal Year**

Section 1. The Annual meeting of the Association shall be held in the month of May each year.

The Association shall also hold two regular meetings each year, known as the Fall Meeting and the Mid-Winter Meeting in the months of September and January respectively.

The Secretary of the Association shall notify the Lodges as to the time and place of said meetings not less than sixty (60) days prior to the meeting.

The President and Board of Trustees shall have the priority and authority to change the date and place of any meeting in case of an emergency.

Special meetings may be called by the President when deemed necessary by a majority of the Trustees upon thirty (30) days written notice to the Secretary of each Lodge.

Two-thirds (2/3) of the accredited delegates from two-thirds (2/3) of the lodges shall constitute a quorum at any Association meeting.

The fiscal year of the Association shall begin on May 1st and end on April 30th of each year.

### ARTICLE V - Revenue

**Section 1.** To obtain the revenue necessary to defray the expenses of the Association, as determined by the Board of Trustees, each Lodge shall pay annually, an amount equal to five dollars (\$6.00) per member; such sum having been determined by the vote at a previous Association meeting.

**Section 2.** The annual dues of a Lodge in good standing that is in financial distress may be remitted in full or in part by the Board of Trustees for good cause shown upon application made to it prior to May 1st of any year. The Trustees may also allow a lodge to pay their current dues in installments under the same criterion of application.

### ARTICLE VI – DISTRICTS AND OFFICERS

**Section 1.** The state shall be divided into three-two (23) districts know as Wyoming East, and Wyoming Northwest and Wyoming Southwest.

- a. Wyoming East shall consist of <u>Sheridan Lodge # 520, Gillette Lodge #2825, Rawlins Lodge # 609,</u>
   Casper Lodge #1353, Cheyenne Lodge #660, Laramie Lodge #582, Lusk Lodge #1797, and
   Torrington Lodge #1726.
- b. Wyoming Northwest West shall consist of Lander Lodge #2317, Riverton Lodge # 1693, Jackson Lodge #1713, Cody Lodge #1611, Gillette Lodge #2825, Greybull Lodge # 1431, Powell Lodge #2803, Sheridan Lodge #520, and Worland Lodge #1908.
- c. Wyoming Southwest shall consist of Jackson Lodge # 1713, Lander Lodge #2317, Rawlins Lodge #609, and Riverton Lodge #1693.

**Section 2.** The officers of the Association shall be a President; a First Vice-President; a Second Vice-President; a Third Vice-President; a Secretary; a Treasurer; a Sargent at Arms; a Chaplain; an Inner Guard; and a Board of Trustees consisting of five (5) elected members, one (1) Trustee to be elected from each District, and two (2) to be elected at large. At least one (1) Past State President of the Association, must be a member of the Board of Trustees at all times. No person may be elected as a Trustee if a member of their home Lodge is then serving on the Board.

Each District shall have an elected Vice-President except for cases where a vacancy is filled as provided in ARTICLE 8 of these Laws.

The Third Vice-President shall be elected from the District of the incoming First Vice-President.

**Section 3.** All elected officers shall be elected at the Annual Meeting of the Association and will serve a one (1) year term; except for the Trustees who will serve a five (5) year term.

The President, immediately after their installation shall appoint a Sargent at Arms, a Chaplain, an Inner Guard, and an Organist (if available) to a one (1) year term.



Two-thirds (2/3) of the accredited delegates from two-thirds (2/3) of the lodges shall constitute a quorum at any Association meeting.

The fiscal year of the Association shall begin on May 1st and end on April 30th of each year.

### ARTICLE V - Revenue

**Section 1.** To obtain the revenue necessary to defray the expenses of the Association, as determined by the Board of Trustees, each Lodge shall pay annually, an amount equal to five dollars (\$6.00) per member; such sum having been determined by the vote at a previous Association meeting.

**Section 2.** The annual dues of a Lodge in good standing that is in financial distress may be remitted in full or in part by the Board of Trustees for good cause shown upon application made to it prior to May 1st of any year. The Trustees may also allow a lodge to pay their current dues in installments under the same criterion of application.

### ARTICLE VI – DISTRICTS AND OFFICERS

Section 1. The state shall be divided into three two (23) districts know as Wyoming EastNorth, and Wyoming Northwest South and Wyoming Southwest.

- a. Wyoming North shall consist of Cody Lodge #1611, Powell Lodge # 2302, Greybull Lodge #1431, Worland Lodge #1908, Sheridan Lodge # 520, Gillette Lodge #2825, Casper Lodge #1353, Cheyenne Lodge #660, Laramie Lodge #582, Lusk Lodge #1797, and Torrington Jackson Lodge #171326.
- b. Wyoming Northwest-South shall consist of Lander Lodge #2317, Riverton Lodge # 1693, Casper Lodge #1353, Lusk Lodge #1797, Torrington Lodge #1726, Laramie Lodge # 582, Cheyenne Lodge #660, and Rawlins Lodge #609. Cody Lodge #1611, Gillette Lodge #2825, Greybull Lodge # 1431, Powell Lodge # 2303, Sheridan Lodge # 520, and Worland Lodge #1908.
- c. Wyoming Southwest shall consist of Jackson Lodge # 1713, Lander Lodge #2317, Rawlins Lodge #609, and Riverton Lodge #1693.

**Section 2.** The officers of the Association shall be a President; a First Vice-President; a Second Vice-President; a Third Vice-President; a Secretary; a Treasurer; a Sargent at Arms; a Chaplain; an Inner Guard; and a Board of Trustees consisting of five (5) elected members, one (1) Trustee to be elected from each District, and two (2) to be elected at large. At least one (1) Past State President of the Association, must be a member of the Board of Trustees at all times. No person may be elected as a Trustee if a member of their home Lodge is then serving on the Board.

Each District shall have an elected Vice-President except for cases where a vacancy is filled as provided in ARTICLE 8 of these Laws.

The Third Vice-President shall be elected from the District of the incoming First Vice-President.

**Section 3.** All elected officers shall be elected at the Annual Meeting of the Association and will serve a one (1) year term; except for the Trustees who will serve a five (5) year term.



**Section 4.** The President shall be the chief executive officer of the Association, He/She shall preside at all meetings, decide all questions of order subject to appeal to the members of the Association, appoint all committees not otherwise provided for subject to the approval of the Board of Trustees, fill all vacancies unless otherwise provided for, and perform such other duties as may be required of him/her by action of the Association and such as are customarily performed by the chief executive officer of a corporation. It shall be mandatory that the President attend the Grand Lodge Convention held during the term of this office. In the event the President is unable to attend, it shall be the duty of the First Vice-President to attend such Grand Lodge Convention. The President shall make a report at the first session of the annual meeting of his/her activities and the work of the Association under his/her administration.

**Section 5.** The Vice-Presidents shall assist the President in the performance of his/her duties and in the absence of the President, or at his/her request, shall preside at the meetings of the Association, in accordance with their seniority.

It shall be the duty of each Vice-President to promote and carry the Association's programs to each of the lodges in <a href="hishis/her">hishis/her</a> District and to hold such District meetings as they may deem advisable for the best interest of the district, The State Association and the Order. They will preside at any District meeting, have a record of the proceedings kept, and report thereon to the Association.

Each Vice-President shall report to the <u>President at least 30 days before the annual meeting of the</u>
Association and to the members at the <u>eachAnnul</u> meeting upon the work they have done during the <u>yearmonths since the last meeting</u>.

It shall also be the duty of the Vice-Presidents to assume the reasonability of directing the activities of the committees assigned to them by the President.

**Section 6.** The Secretary shall attend all meetings of the Association, keep a record of the proceedings, preserve all books and documents, and perform such other duties as are properly required of him/her, and receive all monies from any source whatever, paying the same to the Treasurer at the earlies practicable moment, and providing <a href="https://historices/beta-for-the-treasurer">historices/beta-for-the-treasurer</a> signature. The Secretary shall prepare a voucher for all bills/invoices/debts of the Association and upon his/her approval sign the voucher for payment, and forward said voucher to the Trustee <a href="https://chairmenchairperson">Chairmenchairperson</a>. (See "Appendices" at the end of Article <a href="https://www.hould-be-VIVI">W-should-be-VIVI</a>). The Secretary shall, before assuming the duties of the office, execute and deliver to the Board of Trustees, a faithful performance bond with corporate surety, in an amount fixed by the Trustees, the expense of such bond to be paid by the Association. The Secretary shall be paid a salary of his/her services as fixed by the Trustees.

**Section 7.** The Sargent at Arms shall attend all meetings of the Association and shall execute the orders of the President, assist in preserving order, act as Marshal on public occasions and in case of a closed session shall assist the Inner Guard in examining the qualifications of all persons presenting themselves for admission. They shall select deputies as may be needed to assist in the discharge of <a href="https://her.duties.">his/her</a> duties.

**Section 8.** The Chaplain shall attend all meetings of the Association and perform such duties as are customary to be performed by such officer.

**Section 9.** The Inner Guard shall attend all meetings of the Association and shall be in charge of the doors of the hall in which the meetings are held, <u>and</u> perform such duties as are <u>customary to be</u> <u>performed by such officerincidental to the office of Inner Guard</u>.

**Section 10.** No individual may hold more than one (1) elective or appointive office in the Association at the same time. If an individual who holds an elective office of the Association accepts nomination for election to any other elective office of the Association such acceptance of nomination shall constitute a resignation from the office then held effective at the close of the meeting of the Association, at which the individual has accepted such nomination. The vacancy created by the resignation shall be filled as prescribed by ARTICLE VIII at the same meeting of the Association.

**Section 11.** A member in good standing in any lodge which is a member of this Association shall be eligible for any office of the Association subject to the following:

- a. All candidates for President, Frist Vice-President, Second Vice-President, and Third Vice-President must be a Past Exalted Ruler of a member lodge; and
- b. All candidates for Treasurer must be knowledgeable on accepted bookkeeping practices.
- c. All candidates for Third Vice-President must submit a resume' stating their qualifications for Third Vice-President and past accomplishments in the Association. Letters must be presented to the State Secretary no later than ten (10) days prior to the Mid-Winter Meeting that precedes the Annual Spring Convention at which the election will be held.
- d. All candidates for an elective office of the Association must present a letter of support from their home Lodge signed by the current Exalted Ruler and Secretary of that Lodge and a personal letter of intent to be a candidate for that office. Letters must be presented to the State Secretary no later than ten (10) days prior to the Mid-Winter Meeting that precedes the Annual Spring Convention at which the election will be held, in order that the State Secretary can read all letters of intent at that Mid-Winter Meeting business session.
- e. Any candidate for Secretary must interview with the President, Vice-Presidents and/or Trustees if deemed necessary by those Officers and/or Trustees after their letter of intent to run for Secretary is read at the Mid-Winter Meeting but prior to the election of Officers at the Annual Spring Convention.
- f. Any candidate for Secretary who has not served as Secretary of the Wyoming Elks
  Association must submit a resume' stating their qualifications for the office of Secretary and
  past accomplishments in the Association. Letters must be presented to the State Secretary
  no later than ten (10) days prior to the Mid-Winter Meeting that precedes the Annual Spring
  Convention at which the election will be held.
- g. Any candidate for Treasurer must interview with the President, Vice-Presidents and/or Trustees if deemed necessary by those Officers and/or Trustees after their letter of intent to run for Treasurer is read at the Mid-Winter Meeting but prior to the election of Officers at the Annual Spring Convention.
- h. Any candidate for Treasurer who has not served as Treasurer of the Wyoming Elks
  Association must submit a resume' stating their qualifications for the office of Treasurer and
  past accomplishments in the Association. Letters must be presented to the State Secretary

no later than ten (10) days prior to the Mid-Winter Meeting that precedes the Annual Spring Convention at which the election will be held.

Section 12. The Board of Trustees shall have the power to remove from office any officer, including a Trustee, either elective or appointive, of the Association for good cause shown after notice and hearing. Removal of an officer shall be commenced by the filing of a written complaint by any member in good standing of a membermember lodge with the ChairmanChairperson of the Board of Trustees setting forth the ground for removal. If the ChairmanChairperson of the Board of Trustees is the officer for which removal is sought, the complaint must be filed with the Vice-Chair of the Board of Trustees who shall act in all matters relating to the complaint as presiding officer of the Board of Trustees. Within ten (10) days after receipt of such written complaint, the ChairmanChairperson of the Board of Trustees shall call a special meeting of the Board of Trustees to consider the complaint. If a regular meeting of the Board of Trustees is scheduled within thirty (30) days of the date of receipt of the complaint, the ChairmanChairperson of the Board of Trustees may determine to consider the complaint at that meeting. Written notice of the date, time and place of the regular or special meeting at which the complaint will be considered shall be given to the officer for which the complaint is sought and to the Secretary or Exalted Ruler of each membermember lodge. The power of removal may only be exercised by a majority of the entire Board of Trustees exclusive of any Trustee for which removal is sought.

Section 13. The Treasurer shall attend all meetings of the Association. The Treasurer shall receive all monies of the Association from the Secretary, and sign the receipt indicating he/she has received the funds. Upon receipt of all vouchers approved and signed by the Secretary and Trustee ChairmanChairperson, the Treasurer shall pay all approved bills/invoices/debts against the Association. The Treasurer shall maintain an accurate record of all receipts and disbursements of the Association and shall submit a report of such at each Association Meeting, which states the financial condition of the Association. The Treasurer will provide the Secretary with a copy of all vouchers as they are paid indicating they have been paid (See "Appendices" at the end of Article IV should be VI). The Treasurer shall, before assuming the duties of the office, execute and deliver to the Board of Trustees, a faithful performance bond with corporate surety, in an amount fixed by the Trustees, the expense of such bond to be paid by the Association. The Treasurer shall be paid a salary of his/her services as fixed by the Trustees.

### **Appendices:**

- 1. The Secretary shall prepare a receipt for all monies he/she receives to be turned over to the Treasurer. The receipt will indicate to which income line items the funds are to be credited. The Treasurer shall sign such receipt when the Secretary delivers the funds to him/her and retain a copy of such receipts that shows to which income line item the funds are to be credited.
- 2. The Secretary shall prepare a voucher(s) for all bills/invoices/debts incurred by the State Association and upon his/her approval sign said voucher. All vouchers prepared by the Secretary shall include the expense line item against which the funds are to be charged. Upon his/her approval, the Secretary will forward all signed vouchers to the Trustee ChairmanChairperson for his/her review, approval, and signature at the earliest practicable moment.

- Upon Trustee <u>ChairmanChairperson</u> approval and signature of the vouchers submitted by the Secretary, those vouchers shall be forwarded to the Treasurer for payment at the earliest practicable moment.
- 4. The Treasurer shall deposit all funds received from the Secretary into the appropriate bank account(s) at the earliest practicable moment. All account deposits made by the Treasurer shall note to which income line item account the funds are to be credited. The Treasurer shall prepare a check and make payment to all creditors for all approved vouchers received from the Trustee <a href="ChairmanChairperson">ChairmanChairperson</a> at the earliest practicable moment. All payments made by the Treasurer shall note to which expense line item account the payments are to be charged. The Treasurer shall send a copy of all paid vouchers to the Secretary at the earlies practicable moment indicating the voucher has been paid and settled.
- 5. The Treasurer shall provide a Check Register and associated monthly bank statements, for each account, so the Trustee <a href="ChairmanChairperson">ChairmanChairperson</a> at the earliest practicable moment after they are received. The Check Register shall also be a part of the Treasurer's report, which is to be provided by the Treasurer at each State Meeting.

#### ARTICLE VII - BOARD OF TRUSTEES

Section 1. Immediately following the annual election, the Trustees shall organize as a Board of Trustees by electing a ChairmanChairperson, a Vice-ChairmanChairperson and Secretary. The Board of Trustees, during the interim between meetings of the Association shall take general charge of its property other than cash and securities herein committed to the custody of the Treasurer of this Association, and assume the direction of its affairs. During such interim, it shall be the governing body of the Association, and it shall take such action as may be necessary to protect its interests and promote its objectives. It shall have control of the finances of the Association, except as herein otherwise provided, and shall recommend ways and means of raising funds to defray the expenses of the Association. It shall prepare and submit at the Annual meeting a budget for the ensuing year. The ChairmanChairperson of the Board of Trustees shall approve and sign all vouchers approved and submitted by the Association Secretary, and forward said vouchers to the Association Treasurer for payment. (See "Appendices" at the end of Article IV should be VIVI).

**Section 2.** The proposed budget for the ensuing year shall be approved by the Association's delegates, in annual the Annual session meeting, by a majority vote, before it becomes officially adopted. Amendments thereto may be made from the floor when under consideration. After final approval, no expenditure not therein authorized may be made during the current year, unless considered by the Board of Trustees to be of an emergency nature, and uncommitted funds of the Association, in excess of the budgeted requirements, shall be retained by the Association for the future use in funding its operation.

**Section 3.** The Board of Trustees will act as the Nomination Committee for the Wyoming Elks Association.

**Section 43.** The Board of Trustees shall, from time to time, make such provisions for compensation and expenses of its officers and committee<u>personsmen</u> as it may determine to be in the best interests of this Associations provided, however, no compensation may be paid to the Trustees

unless prior approval thereof has been obtained by majority vote of the members present at a regular or special meeting of the Association.

**Section 54.** No person may be elected to succeed themselves as a Trustee if they have served a full term.

### **ARTICLE VIII – VACANCIES**

**Section 1.** If a vacancy occurs in the office of the President, the vacancy shall be filled by the Nominating and Advisory Committee by the appointment of a Past State President.

**Section 2.** If a vacancy occurs in the office of the First Vice-President, the Second Vice-President shall succeed to the office of the First Vice-President shall succeed to the office of the Second Vice-President and the office of Third Vice-President shall become vacant, the Third Vice-President shall succeed to the office of the Second Vice-President and the office of the Third Vice-President shall become vacant.

**Section 3.** If a vacancy occurs in the office of the Second Vice-President for any reason other than the office of the First Vice-President becoming vacant, the Third Vice-President shall succeed to the office of the Second Vice-President and the office of the Third Vice-President shall become vacant.

**Section 4.** If a vacancy occurs in the office of the Third Vice-President on account of the office of First Vice-President becoming vacant, the vacancy shall be filled from the District in which the First Third Vice-President whose office has been vacated resides by nomination and election at a regular meeting of the Association or at a special meeting called for that purpose.

**Section 5.** If a vacancy occurs in the office of the Third Vice-President on account of the office of Second Vice-President becoming vacant, the vacancy shall be filled from the District in which the Second Third Vice-President whose office has been vacated resides by nomination and election at a regular meeting of the Association or at a special meeting called for that purpose.

**Section 6.** If a vacancy occurs in the office of the Third Vice-President for any other reason the vacancy shall be filled from the District in which the Third Vice-President whose office has been vacated resides by nomination and election at a regular meeting of the Association or at a special meeting called for that purpose.

**Section 7.** If a vacancy occurs in the office of the Secretary or the Treasurer, the President shall, with the advice and consent of the Nominating and Advisory Committee, appoint a successor or successors to fill the unexpired term or terms of either or both of the vacant office(s).

**Section 8.** If a vacancy occurs in any other office in any other office, the President shall appoint a successor to fill the unexpected term of the vacant office.

**Section 9.** If a vacancy occurs on the Board of Trustees the vacancy shall be filled by nomination and election at a regular meeting of the Association or at a special meeting called for that purpose. If the vacancy results from the death, resignation or removal of a Trustee who was elected by the District, the successor Trustee must be elected from that same District.

### **ARTICLE IX – COMMITTEES**

**Section 1.** The President shall appoint the following standing Committees which may consist of not less than three (3) nor in the absence of approval of the Board of Trustees more than seven (7) members. One member shall be appointed <a href="https://chairmanCh

The President with the approval of the Board of Trustees, may name such other committees and sub-committees as they many deem proper, and they may name as many members to such committees and sub-committees as they shall desire subject to the restrictions in Paragraph 1 of this Section.

It shall be the duty of all committee chairmen to submit a written and oral progress report regarding their committee program at all Association meetings. Should for any reason the committee <a href="mailto:chairmanChairperson">chairmanChairperson</a> be unable to attend a meeting they may request that one of the their committeemen or a delegate from their lodge give the report. Also, if for a worthwhile reason a report is deemed unwarranted for a particular meeting, special dispensation may be granted by the President.

**Section 21a.** The Americanism Committee shall familiarize itself with all Grand Lodge Americanism programs. This committee shall make certain it receives all information and materials for such programs, and, in turn, distribute such to all <a href="mailto:member\_member">member\_member</a> lodges. This committee shall expedite such programs within all lodges and lend all aid and assistance to the success of such.

**Section 32.** The Committee on Auditing shall examine and audit all books of the Secretary and the Treasurer, and shall submit annually to the Association its finding and any recommendations it deems for the good of the Association. It shall report specifically whether the Association Budget has been observed.

**Section 3.** The Business Practice Committee shall be made up of knowledgeable and successful businessmen and community leaders who will, upon request, lend their knowledge and advice to any member lodge of the Association who finds themselves in need of such assistance.

**Section 4.** The Committee on By-Laws shall have referred to it and shall report to this Association all proposed amendments to the By Laws. The <u>ChairmanChairperson</u> of such Committee shall be the chief law officer of such Association, and shall assist the President in the interpretation of its Law. The Committee shall also perform a general review of these laws annually.

**Section 5.** The Committee on Credentials shall examine the credentials of all delegates, alternate delegates and others with the privileges of delegates, and shall have power to pass upon the regularity of the same. It shall make a preliminary report immediately after the opening of the annual or any special meeting, and a final report immediately prior to the close of such meeting.

**Section 6.** The Committee for the distinguished Elks shall establish a program to search out members of the Order who have set themselves apart from others by their actions and deeds for Elkdom. When the committee has made their selection, it shall give recognition to the recipient in a manner worthy of <a href="https://distriction.org/linearing-new-normal-new-new-normal-new-normal-new-normal-new-normal-new-normal-new-normal

**Section 7.** The Drug awareness Committee shall be aware of all of the grand Lodge programs on drug abuse and shall establish a program within the Association following the Grand Lodge guidelines. The <a href="mailto:chairmanChairperson">chairmanChairperson</a> of this Committee shall, from time to time, attend any Grand Lodge seminars on drug abuse and make a report thereof to the Association at any of the Association meetings.

**Section 8.** The Government Relations Committee shall consist of members familiar with not only the Legislature, but with all laws and regulations that have any effect on the Order or its <a href="subordinatemember">subordinatemember</a> lodges. It shall be the duty of this committee to maintain a current knowledge of such legislature and report to the Association and its <a href="member-member">member</a> lodges any changes or proposals that might in anyway have a nay effect on them.

**Section 9.** The Grand Lodge Convention and Housing committee shall keep the members of the Association informed as to all meetings of the Grand Lodge and where the members of the this Association shall be house when attending such sessions.

**Section 10.** The Historical Committee shall be comprised of members of the Association who have knowledge of the past workings of this Association. They shall search out any of the historical happenings and events of the Association and report to the Association from time to time.

**Section 11.** The Committee for Hoop Shoot shall familiarize itself with all of the material sent forth by the Grand Lodge <u>Elks National Foundation</u> Hoop Shoot Committee to all of the <u>subordinatemember</u> lodges. It shall establish a program that correlates with the Grand Lodge guidelines and shall promote and perpetuate the program within the confines of the Association.

**Section 12.** The Lapsation Committee shall work closely with the secretaries of the subordinate lodges of the Association and the Secretary of the Association to assist in the efforts to eliminate the dropping of delinquent members from the rolls. The Chairman of this committee shall make a report to the Association at any of the meetings.

**Section 123.** The Law Enforcement Officer of the Year Committees hall comprise of members of the Association that may or may not e members of the law enforcement community. They shall select the recipient of this award after they have been nominated from the <u>subordinatemember</u> lodges of this Association and shall present a proper award to the recipient at the Annual meeting of the Association.

**Section 134.** The Lodge Activities Committee shall familiarize itself with all of the programs of the Lodge Activities Committee of the Grand Lodge and shall disseminate that information to all of the <u>subordinatemember</u> lodges of the Association and report to the members at the meetings of the Association.

**Section 145.** The Major Project Committee shall be divided into two (2) categories. Number one (1) shall be the Association Scholarship Program. Number two (2) shall be the Needy Youth Program. The duties of each of these two (2) programs shall be set forth as follows:

- 1. Scholarships State Association
  - a. The scholarship committee shall be in charge of all of the scholarships awarded by the Association. It shall receive and select the winning recipients from the <u>brochures</u> applications submitted and make a report at the Annual meeting of the Association.
- 2. Needy Youth
  - a. The Needy Youth Committee shall be comprised of <a href="https://doi.org/10.20/10.20/">https://doi.org/10.20/</a> The Needy Youth Committee shall be comprised of <a href="https://doi.org/10.20/">three (3)two (2) members District</a> Chairs, one (1) from each district in the state and a Chairperson. They shall review all applications presented to them and shall approve or disapprove such

- application(s). Their guidelines for approval of the Needy Youth shall be established and followed by the District Chairman.
- b. The Committee Chairperson shall make a report to the members of the Association at each business meeting.

The Committee Chairman of the Major Project Committee shall be in charge of both categories and shall make a report to the members of the Association at their meetings and a final report of all scholarships of the Association and the expenditures for the Needy Youth Committee at the Annual meeting of the Association.

**Section 156.** The Membership Committee shall keep the members of the Association informed as to the status of all of the <u>subordinatemember</u>d lodges at each meeting of the Association and report the membership loss or gain therein at each <u>business meeting</u>.

**Section 167.** The New Lodge Committee shall search for any possible locations for the establishment of new lodges within the State. The committee shall be aware of the parameters of a new lodge as set forth by the Grand Lodge and shall submit a written report to the Association at the Annual each business meeting or any special meetings.

**Section 178.** The Elks National Foundation Committee shall promote the Elks National Foundation within the Association and all <a href="mailto:member-llodges">member-llodges</a>. This committee shall familiarize itself with all Grand Lodge Programs concerning the Foundation and will, in turn, convey such information and material to all <a href="mailto:member-lodges">member-lodges</a>. It shall be the duty of this committee to assist all lodges in their programs and to promote the fullest intent of the Order.

Section 189. The Committee for Officer Training shall utilize the Grand Lodge Training program and shall correlate it as such. It shall encourage all officers of subordinate lodges to participate in the program. schedule and conduct the Leading Knight/Secretary Training, scheduled for late February or early March each year. The Committee shall promote this event to all member Lodges to assist the Lodge leaders in the execution of their duties.

**Section** 1920. The Public Relations Committee shall promote and perpetuate to the print and electronic media anything worthy or merit that will enhance the image of the Association and of our Order.

**Section 201.** The Publications Committee shall be in charge of any publication that may be published <u>via electronic means</u> on behalf of the Association<del>, and They shall be able to negotiate with any reputable firm either in State or out of State, that meet the guidelines established by the Association, and disseminate the news of the Association to all members.</del>

**Section 212.** The Committee on Resolutions shall have referred to it all proposed resolutions. It shall make a written report to each <u>session business meeting</u> of the Association.

**Section 223.** The Ritual Development Committee shall promote and perpetuate the entire ritualistic program to all member -Lodges of the Association. At a convenient time during the course of the year, but not in conjunction with each other, it shall plan and hold a ritual clinic for all of the subordinatemember lodges. The content shall be conducted in a fair and impartial

manner so as not to discourage the participants from competing. When called upon, the Ritual Development Committee shall render aid and advice to any <u>subordinatemember</u> lodge endeavoring to start or renew a ritual team.

**Section 234.** The Veterans Service Committee shall have a <u>ChairmanChairperson</u> appointed by the President with the approval of the Elks National Service Committee. This committee shall encourage visitations, provide entertainment, and promote beneficial activities for our hospitalized Veterans and shall generally promote and stimulate participation by <u>member member IL</u>odges in the programs of the Elk's National Service Commission.

Section 245. The Wyoming Elks Association WEST Fund Trustees is established to promote and enhance the perpetual fund that has been established within the Association. The President shall appoint a ChairmanChairperson and three two (23) other members, one (1) from each district, to promote and coordinate the efforts and donations from the members. The ChairmanChairperson shall report the progress at each business meeting of the Association.

Section 256. The Youth Activities Committee shall familiarize itself with all Grand Lodge Youth Activity programs available to <a href="subordinatemember">subordinatemember</a> lodges. It shall, in turn make certain it receives all information and materials for such programs from the Grand Lodge and <a href="distribute-disseminate">distribute-disseminate</a> the same to the <a href="member-member-llodges">member llodges</a>. It shall coordinate all of the brochures presented to the committee for the scholarship awards and submit winning brochures after they have been judged to the Grand Lodge for consideration. It shall be the duty of this committee to expedite these programs within all participating lodges and to lend assistance and aid necessary to their success and make a written report there of to the Annual at each business meeting of the Association.

**Section 276.** The Advisory Committee shall consist of all Past State Presidents. The Advisory Committee shall advise with and extend its counsel to all State Officers and Committees, and shall have the following duties and authority

- a. To Elect its Officers
- c. To adapt rules for the conduct of its business
- d. To appoint Sub-Committees from its membership
- e. To hold meetings and to specify the dates and places for such meetings
- f. Recommend to the State President areas for State Committee assignments
- g. To recommend candidates for State Officers
- h. To recommend State Committee assignments
- i. To recommend constitutional and statutory amendments
- i. To assist the State President
- k. To recommend the removal of State Officers and State Committee Chairpersons
- I. To engage in other activities which will promote the Good of the Order.

**Section 278.** The Committee on Site Selection shall consist of five (5) Past State Presidents who shall be responsible for seeking convention locations for State Association meetings. To review bids for compliance to Association specifications and submit their recommendations to the Advisory Committee for their approval. The Site Selection Committee shall have responsibility of assuring all provisions of the accepted bid are adhered to by the responsible party at the Lodge hosting the meeting.

**Section 289.** The Committee for Soccer Shoot shall familiarize itself with all of the material sent forth by the Grand Lodge Soccer Shoot Committee to all of the <u>subordinatemember</u> lodges. It shall establish a program that correlates with the Grand Lodge guidelines and shall promote and perpetuate the program within the confines of the Association.

**Section 2930.** The 50 / 50 Fundraiser Lucky Knight Shoot Out Committee shall be responsible for overseeing the operation of the 50 / 50 this - Fundraiser. Duties shall be as follows:

- a. Coordinate the fund raising effort with the Chairperson of the Wyoming Elks State Trust, Chairperson of the Elks National Foundation, and the Secretary of the Wyoming Elks Association.
- b. Shall be responsible for receiving money from the 50/50 Lucky Knight Shoot Out fundraiser, and see that all Lodges receive credit for money donated by its members.
- c. Shall be responsible for the printing, stuffing, and mailing of all fundraising material.
- d. Shall be responsible for correlating and allocating all funds and prizes and submit to the State Secretary and Treasurer and accounting of all funds and expenses.
- e. Shall be responsible for maintaining a record of each individual entry submitted.
- f. Shall be responsible for the accounting of the names and addresses of the winners, the amounts of winnings and the amount donated to the Lodge competing in the Grand Lodge Ritual Contest. of all direct donations to the Wyoming Elks State Trust received during the fundraising, and submit the record to the State Secretary-Treasurer along with the donations keeping them separate from the funds of the fundraiser.

**Section 30.** The Committee for Dictionaries shall familiarize itself with all of the material sent forth by the Grand Lodge Dictionary Committee to all of the member lodges. It shall establish a program that correlates with the Grand Lodge guidelines and shall promote and perpetuate the program within the confines of the Association.

Section 31. The Committee for Hides for Vets shall familiarize itself with all of the material sent forth by the Grand Lodge Hides for Vets Committee to all of the member lodges. It shall establish a program that correlates with the Grand Lodge guidelines and shall promote and perpetuate the program within the confines of the Association.

Section 32. The Committee for Protocol shall familiarize itself with all of the material required to provide assistance to the Lodge hosting a Wyoming Elks Association meeting. It shall establish a program that provides all necessary materials to the Wyoming State President and the Hosting Lodge to promote a successful meeting with appropriate protocols.

Section 31. The Friends of WEST Committee shall assist the Lodges of the Wyoming Elks Association in their fundraising efforts in behalf of the Wyoming Elks State Trust by acquiring promotional incentives to be used as a prize at the annual Friends of WEST drawing.

### ARTICLE X -RELATIONS WITH GRAND LODGE

**Section 1.** The Secretary of the Association shall furnish from time to time to the Grand Exalted Ruler, the Grand Secretary, and the <a href="mailto:ChairmanChairperson">ChairmanChairperson</a> of the Committee on State Association of the Grand Lodge, the following:

- a. Copies of its Constitution, By-Laws, Rules and Regulations and amendments thereto.
- b. A report on the proceedings of each Annual meeting, including the report of its Treasurer.
- c. All official circulars issued by it or under its authority.
- d. A list of the Lodges who are members of the Association.
- e. A list of its Officers immediately following each Annual meeting, with the correct post office address of each Officer.

**Section 2.** The Association shall observe strictly the provision of the Constitution and Statutes of the Grand Lodge relating to State Associations. No questions of political or sectarian character shall be introduces at a meeting of the Association, and no person shall be directly or indirectly endorsed for any public or Grand Lodge Office. A resolution recommending action by the Grand Lodge shall be filed with the Grand Exalted Ruler and the Grand Secretary and shall not be given publicity until it has been submitted to and approved by the Grand Lodge, and then only in accordance with the Laws of the Order.

A two-thirds (2/3) affirmative vote of those present and entitled to vote shall be required to adopt any amendment. Amendments shall be effective as of the date to adoption unless some other effective date is set forth in the amendment.

### **ARTICLE XII -AMENDMENTS**

**Section 1.** Amendments to these By-Laws must be presented in writing at a meeting and then shall be referred to the Committee on Laws. The written report of the Committee on Laws thereon shall deliver to the Secretary as soon as possible.

The Secretary shall immediately send to each <u>member member</u> Lodge, a copy of the proposal along with the report of the Laws Committee thereon.

Thereafter at any meeting, it may be considered under the head of "New Business." Amendment thereto, may be made from the floor and acted upon before action on the original Amendment, this requires a two-thirds (2/3) affirmative vote of those present and entitled to vote to amend the Amendment.

A two-thirds (2/3) affirmative vote of those present and entitled to vote shall be required to adopt any amendment. Amendments shall be effective as of the date to adoption unless some other effective date is set forth in the amendment.

### ARTICLE XIII - CHARITABLE AND BENEVOLENT FUND

**Section 1.** A permanent and irrevocable Fund is hereby created and established to be known as the Wyoming Elks Association WEST Fund, the corpus of which shall be invested in income producing securities and property; the income shall be applied in such manner as the Trustees thereof may determine for the furtherance of charitable, educational and benevolent purposes in Wyoming provided, however, that money or property may be received by the Trustees for purposes other than accumulation in the corpus of the Trust if the donors thereof so direct.

Section 2. The Fund shall be administered as a single fund by a Board to be known as the Wyoming Elks Association WEST Fund Trustees. This board shall consist of a ChairmanChairperson, and three members of the Association to represent the three two Districts of the State, NW, E, SWEast, West. Immediately upon the taking effect of these By-Laws, the President shall appoint a ChairmanChairperson to serve for a period of one year and/or until hishis/her successors are duly appointed and qualifies, and the first three Trustees, as outlined above, to serve for periods of one, two and three years respectfully. Thereafter, and at each Spring Meeting of the Association, the President shall appoint a ChairmanChairperson to serve for one year, and one Trustee to serve for a period of three years and/or until the successors are duly appointed and qualify. All appointments shall be confirmed by a majority vote of the Association in meeting assembled, prior to their taking office. Vacancies may be filled

temporarily by Presidential appointment to serve until the next regular meeting of the Association at which time a nomination and appointment to fill the remaining term of the vacancy shall be made in the same manner as regular appointments. The Association President, Five Year Trustee and Secretary shall serve as ex-officio Trustees during their terms of office having a full voice in Board deliberations and decisions. The Exalted Ruler of each Lodge shall appoint a Charitable and Benevolent Committee, the <a href="ChairmanChairperson">ChairmanChairperson</a> of which shall work with the Trustees in his area to further the purposes of the Fund.

**Section 3.** The Trustees are hereby given and granted plenary powers to promote, develop and administer the Fund to accomplish its charitable, educational and benevolent purpose; are hereby authorized and empowered to receive from all sources any monies, securities or other property transferred to them in trust for the purposes for which the Fund is established; to invest same in income producing securities or other property, and to sell, transfer and reinvest same in such a manner as shall best safe guard the Fund and assure the continuity of its income; to accumulate monies, securities or other property therefore for the purposes of any gift, devise or bequest made to this Fund inconsistent with any of the terms hereof shall be observed in respect to the funds or property so given, devised or bequeathed.

**Section 4.** Trustees shall serve without salaries or emoluments. The necessary expenses of all administration of the Fund shall be paid from the general funds of the Wyoming Elks Association and budgeted thereof.

Section 5. The Trustees shall have power to adopt rules for their meetings and the conduct of their business; to enter into contracts for any and all necessary purposes in connection with the duties of said board; to have custody of the funds committed to such Board by authority of the Association; to require bond in such penal sum as may be determined, from such Officers or members as may have actual custody of funds or securities; report at each meeting of the Association on its activities, income and expenditures, as well a prospective work and activities for the future; and to do and preform such other at and duties as may be properly incident to those specifically mentioned herein. Disbursement of all monies from the Wyoming Elks Association WEST Fund shall be upon order of the Trustees thereof, such order, setting forth the purpose therefore, to be signed by the ChairmanChairperson and forwarded to the Association Secretary, who shall draw and sign a voucher on the Fund, returning same to the ChairmanChairperson for hishis/her countersignature and distribution.

**Section 6.** All mater not herein covered Shall be governed by the Constitution and Laws of the Grand Lodge, which will likewise prevail in all matters herein expressed that conflict herewith.

**Section 7.** The Rules of Order prescribed by the Grand Lodge for the <u>subordinatemember</u> Lodges shall govern all parliamentary procedure, and in any situation arising and not covered thereby, Roberts Rules of Order, as last, revised, shall be followed.

**Section 8.** Should the Wyoming Elks Association be disbanded, the substance of income producing securities and property, accumulated for its Charitable Educational and Benevolent purposed shall be delivered in its entirety to the governing body of the organization known as the Benevolent and Protective Order of Elks of the United States of America. The contents shall then be placed in the Elks National Foundation fund which in itself is recognized by the Internal Revenue Service as exempt under Section 501 (c) (3).

### Section 9. Elks Angels Fund.

- 1. A permanent trust is hereby created and established to be known as the Elks Angles Trust. The Trust shall be administered as an entity of the Wyoming Elks State Trust. Fund received, for this Trust, shall be held separate from the corpus of the Wyoming Elks State Trust. The corpus of the Elks Angles Trust shall be invested in income producing securities and property; the income of which shall be applied in such manner as the Trustees thereof may determine for the furtherance of educational purposes for the families (see appendices 1) of members of the Armed Forces from Wyoming who have served or are currently serving in the military forces of the United States of America on the war on terror since 9/11/2001. Money or property may be received by the Trustees for purposes other than accumulation in the corpus of the Trust if the donors thereof so direct.
  - Bequests shall be made to educational institutions of learning as directed by the successful applicant. The bequest shall be made in the name of the Service member for the education of their family member.
- 2. The Trustees of the Wyoming Elks Association WEST Fund shall meet annually and determine the number of bequests, and the amount of the bequests. They are directed to use their collective sound judgement to both preserve the corpus for future bequests and provide as much assistance as possible to the family members of Service members. Nether directive shall be considered to take precedence over the other. Bequests will be given until all bequests allocated for that year have been assigned. Any further requests will be denied, but the family members shall be advised that they are welcome to re-apply the following year. Nothing will preclude family members, as defined, from submitting a separate request for funds. A qualified family member may apply for a bequest in multiple years by submitting a current application to the Elks Angles Fund Committee each year.
- 3. The Trustees of the Wyoming Elks Association WEST Fund are hereby given and granted plenary powers to promote, develop and administer the Fund to accomplish its educational and purposes; are hereby authorized and empowered to receive from all sources any monies, securities or other property transferred to them in trust for the purposes for which the Fund is established; to invest same in income producing securities or other property, and to sell, transfer and reinvest same in such a manner as shall best safeguard the Fund and assure the continuity of its income; to accumulate monies, securities or other property as a part of the corpus, for purposes of distribution within the scope the Fund; provided, however, that the terms of any gift, devise, or bequest made o this Fund inconsistent with any of the terms hereof shall be observed in respect to the funds or property so given, or bequeathed.
- 4. The Trustees shall have power to adopt rules for their meetings and the conduct of their business; to enter into contracts for any and all necessary purposes in connection with the duties of said board; to have custody of the funds committed to such Board by authority of the Association; to require bond in such penal sum as may be determined, from such Officers or members as may have actual custody of funds or securities; report at each meeting of the Association on its activities, income and expenditures, as well a prospective work and activities for the future; and to do and preform such other at and duties as may be properly incident to those specifically mentioned herein. Disbursement of all monies from the Elks Angles Trust Fund

- shall be upon order of the Trustees thereof, such order, setting forth the purpose therefore, to be signed by the ChairmanChairperson, counter signed by one of the Trustees and distributed.
- 5. At any time, the Elks Angles Fund, upon a majority vote of the <a href="ChairmanChairperson">ChairmanChairperson</a> and Trustees, the substance of income producing securities and property, accumulated for its educational purpose shall be delivered in its entirety to the corpus of the Wyoming Elks Association WEST Fund.
- 6. Trustees shall serve without salaries or emoluments. The necessary expenses of all administration of the Trust shall be paid from the general funds of the Wyoming Elks Association and budgeted thereof.

**Appendices:** Family, for the purpose of this Trust, shall be defined as follows:

- 1. The Family of the Service member is defined as the children of the service member, adopted or natural.

Since this year's Hoop Shoot season will NOT happen at the State, Regional, or National levels, there is not much to report on Wyoming Hoop Shoot at this time. I have not received any information from the Elks National Foundation as to what information they have sent your Lodge Director. I do not know when the ENF appointed District Directors might be trying to schedule their contests.

If your Lodge is going to try to have a Local Contest, please adhere to the rules as outlined in the "Official Contest Manual".

The manual is included in the Hoop Shoot Packet sent to your Lodge (after your Hoop Shoot Coordinator has notified the Foundation of your contest date).

A brief summary of the rules: "*Health and safety are the only priorities* – Masks MUST be worn by all attendees at all times.

Social distancing guidelines must be enforced for all contests.

Each shooter will be asked to bring **their own basketball** that only **they will use** during the shoot.

Line judges and rebounders must use sanitizer/sterilizer between shooters to maintain sanitary measures.

All State and Local Mandates must be followed and the

"coronavirus acknowledgement" must be signed by all contestants, guests (if allowed), and volunteers upon arrival at the contest venue."

ENF will enter the names of any District Hoop Shoot Champions into a random raffle at the end of the year to award prizes.

The WEST funds sheet indicates a negative checking account balance, but there is still plenty of funds in there for the Elks Angels portion of that account. We will be getting some investment funds transferred into the checking account as we did budget \$30K to be put in there for our needy youth project, which has not been done yet. There is also a question on putting some ENF Funds into the WEST account for needy youth, but I am not for sure on that. There is a \$10K line item in the ENF budget for the Major Project-Youth account, but I was under the impression that was for "special requests" on an "as-needed" basis and was not to be transferred into the WEST account. This issue will be discussed at the State Officers Meeting scheduled for Friday, 1-8-21.

Our investments continue to do pretty well and are still growing as we meet today. We still have not been able to get one of our investments under the WEST Investment umbrella. There is some outstanding paperwork that we need to get in line and sent to the investment firm so that can be completed. Hopefully, we will get that done before the Spring Convention.

If anyone has any questions on our finances and/or investments, please let me know and I will try to answer them – or direct you to talk to Jerry.
